THIS AGREEMENT made on _____, by and between, Richard R. Bruckman, (stallion owner) and _____.(mare owner).

- STUD fee:** \$ 500.00 Cowboy Picasso .
\$ 500.00 Rock "N" Sugar Boy .
- First Shipment:** Mare owner agrees to pay said money as follows: a. Booking fee of \$ 150.00 is required and to be returned with this signed contract, which is non-refundable. The booking fee will be accounted as part of the Stud Fee. In addition, a disposable container will be purchased from Rock N Easy Ranch for \$35.00 (**Waived** if box is returned within 15 days). The Stud Fee (minus the booking fee) will be paid prior to first shipment. The disposable container cost will be billed to you after first shipment if container is not returned. Shipment will arrival the next day by Priority FedEx delivery, exact time will depend on shipping address.
- Fees for Additional Shipments:** If the first shipment does not bring the Mare into foal, and such is verified by an Ultrasound test after 18 to 22 days from AI date, additional Shipments will be provided. The mare's status must be documented within 7 days of the Ultrasound test by a licensed veterinarian. Fee for Additional shipments within the same season will be a Collection/Lab fee of \$150.00. The original disposable container can be used if returned to Rock "N" Easy Ranch in usable condition or else an additional \$35.00 will be billed.
- Mare Owner warrants** that said mare is free from disease or infection that could affect the breeding of a Live Foal. MARE must have recent uterine culture (unless Maiden) and be up to date on all vaccinations and worming.
- Live Foal Guarantee:** Live foal means "foal shall stand and nurse". If contracted mare does not produce a live foal, a follow-up breeding heat cycle or return season will be guaranteed if, and only if, Stallion owner is provided with a written statement of details of the foal's death and is provided within 10 days by a licensed veterinarian. If such statement of details is not received on a timely basis, guarantees given by stallion owner herein shall be null and void. This clause is also binding in case of abortion or Still Born. The stallion owner will not refund the breeding fee, the breeder only agrees to rebreed the mare within a 15 month period or the rebreed right shall be lost. There will be a \$150.00 collection/lab fee per additional shipments.
- Wavier of Liability:** Rock N Easy Ranch, veterinarians, and any other parties involved, shall be saved harmless of liability for any loss from fire, theft, escape, sickness, disease, injury, death or

other harm suffered by Mare and/or foal whether or not deemed to be caused by negligence. Rock N Easy Ranch does not carry any form of insurance on client horses. The client assumes no liability for injury, sickness, or death of the jack, owners, or employees caused by the Jack collection.

7. **Registration:** Stallion Owner agrees to execute all necessary documents for the registration of the offspring of the breeding.
8. **Agreement:** This agreement shall be a binding contract when signed and accepted by both parties. This agreement shall be governed by the laws of the State of California, and venue shall be in Kern County, California. In the event counsel is retained to enforce the provisions of this agreement, the prevailing party shall be entitled to collect all reasonable attorney's fees and costs.
