

# Breeding Booking Contract for Season of 2008

THIS AGREEMENT made on \_\_\_\_\_, by and between, Richard R. Bruckman, (Jack owner) and \_\_\_\_\_(mare owner).

1. **STUD fee:** \$ 500.00 Cowboy's Picasso.  
\$ 500.00 Rock-N-Sugar Boy.
2. **Payment:** Mare owner agrees to pay said money on the events indicated below: a. Booking fee of \$ 150.00 is required, and to be returned with the signed contract, which is non-refundable. The booking fee will be accounted as part of the Stud Fee. The Stud Fee (minus the booking fee) will be paid upon delivery of Mare to Ranch.
3. **Mare Care and Breeding Services:** In addition to the above Stud Fee, Mare owner agrees to pay the following:
  - Seven dollars per day for Mare Care. This fee includes feed and daily stall cleaning. Any supplements or special feed to be provided by Mare owner. Mare care and all other unpaid expenses will be due and payable before the mare leaves the premises.
  - A licensed Vet will be used to Ultrasound Mare for examination of the reproduction system and mares heat cycle status (\$ 42.00). Note: any services performed by a licensed Vet will include a “% of Shared Ranch Call” Charge.
  - A Rock ‘N’ Easy Ranch Tech will use the Prostin Shot (\$26.00) to control mares heat cycle to co-ordinate with the Jack semen collection schedule, and will AI mare (twice in heat cycle). In some cases the chances of Mare settling in Foal can be significantly raise with a HCG Shot (\$35). If the owner does not want to use the HCG shot to speed up Ovulation, it should be so stated before breeding starts. First Collection and AI procedure is part of Stud fee.
  - After AI procedure, the mare owner may pick-up mare and have 18 day “Preg.Check” performed by owner’s Vet. or leave mare (mare care charge applies) and have Ultrasound 18 day check (\$42) performed at Ranch. Leaving the Mare for the 18 day “Preg.Check” allows the Mare to be on site if a follow-up Breeding is required.
  - If the first AI procedure does not bring the Mare into foal, and such is verified by an Ultrasound test after 18 days from AI date, additional AI’s will be provided. With Mare owners permission any mare not settling on first AI cycle may stay or return to Ranch for follow-up AI breeding. Prostin Shot, Ultrasound, HCG Shot, and Mare Care costs apply.

Fee for any additional Breeding within the same season will be a Handling/Lab fee of \$150.00.

- The owner of any Mare needing sedation to enter and/or stand in Breeding stock will be charged for sedation shot by Vet. Mare owner will be consulted prior to breeding.
  - Any special treatments will be at expense of Mare owner and will be consulted prior to breeding
4. **Live Foal Guarantee:** Live foal means "foal shall stand and nurse". If contracted mare does not produce a live foal, a follow-up breeding heat cycle or return season will be guaranteed if, and only if, Jack owner is provided with a written statement of details of foals death within 10 days by a licensed veterinarian. If such statement of details is not received on a timely basis, guarantees given by Jack owner herein shall be null and void. This clause is also binding in case of abortion and Still Born. The Jack owner will not refund the breeding fee, the breeder only agrees to rebreed the mare within a 15 month period or the rebreed right shall be lost. If a Mare requires a follow-up breeding in the current year or a return season, Prostin Shot, HCG Shot, Ultrasound, and Mare Care costs apply. Fee for any additional Breeding within the same season or return season will be a Handling/Lab fee of \$150.00.
  5. **Veterinarian Certificates:** Mare Owner warrants that said mare is free from disease or infection that could be transmitted to other horses and will provide a shot record showing current vaccinations. If mare is from out-of-state, mare owner agrees to provide, upon arrival, a veterinarian certificate, showing freedom from disease or infection including proof of a negative Coggins test for EIA (Coggins test must be within 60 days prior to arrival)
  6. **Jack Owner:** reserves the right to reject any mare that is in poor condition or one that is unmanageable. Mares that are not halter broken will not be accepted. MARE must have recent uterine culture (unless maiden) and be up to date on all vaccinations and worming. Dependent on Mare's Breeding History, Culture may be done upon arrival with owner's permission and at owner's expense.
  7. **Veterinarian Care:** Jack Owner agrees to use reasonable care and caution for said mare while in his possession or control, pursuant to this agreement, and is authorized to obtain any necessary reasonable veterinarian care as required, but only after taking steps to contact Mare Owner. Any resulting fees from such emergency will be the responsibility of Mare Owner.
  8. **Wavier of Liability:** Rock N Easy Ranch, veterinarians, and any other parties involved, shall be saved harmless of liability for any loss from fire, theft, escape, sickness, disease, injury, death or other harm suffered by Mare and/or foal whether or not deemed to be caused by negligence. Rock N Easy Ranch does not carry any form of insurance on client horses. The client assumes no liability for injury, sickness, or death of the jack, owners, or employees caused by the mare and /or foal.
  9. **Registration:** Jack Owner agrees to execute all necessary documents for the registration of the offspring of the breeding.
  10. **Agreement:** This agreement shall be a binding contract when signed and accepted by both parties. This agreement shall be governed by the laws of the State of California, and venue

shall be in Kern County, California. In the event counsel is retained to enforce the provisions of this agreement, the prevailing party shall be entitled to collect all reasonable attorney's fees and costs.

I, the undersigned, do hereby certify that I am the Mare Owner named herein, or a duly authorized agent or lessee thereof, and as such have the authority to enter into and be bound by, this contract, as witnessed by my signature. I also certify that I have read and understood the terms of this contract.
